RELEVANCE OF ROTATIONAL PRESIDENCY IN A DEMOCRATIC SETTING: A CASE STUDY OF NIGERIA.

Abstract

The major aims of this research work are to explore and describe "The relevance of rotational presidency in a democratic setting," and Nigeria as a sovereign State was used as a case study. Historical analysis was used in the research. The theory of conflict perspective by karl Marx was used as a theoretical Framework to draw the road map on the genesis, rationale and quest for power struggle and dominance in our contemporary societies. While Nigeria's theory of federal character principle was used as empirical Framework was used to highlight and create enabling political plain and measures to submerge the conflict perspective towards ensuring equity and equal opportunity to all Nigeria citizens in public service and National Government. Some of findings of this research showed that rotational presidency is the most preferred for fair treatment in any democratic setting. Recommendations were made among which is that Nigeria government should provide constitutional models (standard) upon which the electoral umpire should draw their guidelines in working out national scheme which every eligible party shall uphold without refusal in Nigeria.

Introduction

Background to the Study:

The major aims of this research work is to explore and describe "The relevance of rotational presidency in a democratic setting." And Nigeria as a sovereign State will be used as a case study.

This stem from the fact that she is facing a big challenge of national leadership question in a global view, owing to her inability to uphold the principle of rotational presidency among six geopolitical zones of the country viz: South East, South, South West, North west and north

central, rotational presidency would have been a lasting solution to the war of getting power at the centre.

Again, the more worrisome blunder is that the quest to get power at the centre has resulted to political instability, unusual frequent change of government between civilian and military government, despite the fact that she had attained fifty-five (65) years old as an independent state in west African, since 1960.

More so, the neglect and untrue practice of the principle of rotational presidency in Nigeria has numerous undisputable consequences in global view such as: agitation for power, Military coup detat, Issue of secession among others.

This research work shall be giving deliberate analysis on the relevance of rotational presidency in a democratic setting and it's sustainability in Nigeria political system through its entrenchment in Nigeria constitution and electoral act, to promote ethnological representation and the feelings of belonging, since it is the only leadership by rotation that will grant all section or ethnic group to participate in the leadership of Nigeria at the central government.

Again the concept of rotational presidency will be extensively discussed in this work in relation to some scholar's view. To submerge the ethnic political ideology and create rooms for leadership competence, viable political stability, peaceful democratic atmosphere, unity, progress and co-operative existence of Nigeria as a sovereign State.

In this research also, the theory of conflict perspective by karl Marx will be highlighted to draw the road map on the genesis, rationale and quest for power struggle and dominance in our contemporary societies. While Nigeria's theory of federal character principle will be highlighted to actually create enabling political plain and measures to submerge the conflict perspective towards ensuring equity and equal opportunity to all Nigeria citizens in public service and National Government.

This research will also offer analyses on the powerful argument about rotational presidency in Nigeria democratic setting and the pragmatic authenticity of rotational presidency principle in Nigeria in relation to the views of different Scholars.

Again, the empirical survey on the national debate of August 16th and 24th 1995 Drafting constitution for rotational for rotational presidency and democratic principle in Nigeria, shall be made to determine the opinion of different geopolitical zones and the view of both the advocates and antagonists of rotational prudency in Nigeria.

Statement of the problem

The pluralistic and sharply divided societies all over the world attempt to manage their diversities and divisive tendencies through one or combination of alternative policies in the organization and management of their public services and power sharing for better or best performances, equitable and more than 250 ethnic group is not in exception. Therefore, rotational presidency in Nigeria political system and democratic structure is the only policy which if

properly, carefully conceived, and use will serve as a panacea for submerge ethnological power domination and marginalization but provides an ample opportunity for entre-seeking and centre-feeling forces to ensure peacefully and co-habit on agreed teams of unity in diversities which has been the "National leadership questions" in Nigeria.

But contrary to the view of "Rotational presidency" Nigeria's case has turn out to be delicate and mere expression of Joke, for of the fact that the accusation of "Power domination at the centre or national Government by the North ethnic group in Nigeria remained obvious, tracing the historical background of head of state and presidents from 1960 till date. These combinations of accusations and allegations arising from these questions constitute the problems that this research work is aiming to answer and solve at the end.

purpose of the study

This research work aims at achieving the following purpose:

Explore the relevance of rational presidency in Nigeria democratic setting.

Explore/Identifies the causes of political instability.

Predict the consequences for neglect and untrue practice of the principle of rational presidency in Nigeria Government.

Suggest policies to consolidate unity in diversity and prevent national problems in Nigeria.

Significant of the study:

Findings of this research would be of help to Nigeria in no small measure to overcome the said "national leadership questions" that are ravaging Nigeria image and global view.

The research will promote equal participation by all geopolitical zones of Nigeria in National Government.

It will also promote unity in diversity and oneness in Nigeria, as this will give ample opportunity for minority groups of this country to enjoy the slot at the national Government.

Equally, it will go a long way to promote the principle of Federal character, that enable all regions, states, Local Government to have equal representations at the national Government and public service.

Scope of the Study

This research work shall be strictly restricted to investigate "The Relevance of Rotational presidency in Nigeria democratic setting" coupled with such an issue that relates to effectiveness or reality of the rotations of national leadership in Nigeria from onwards.

This study is concerned mostly on the power rotation/sharing of national leadership or political power as regards to Nigeria presidents across different ethnic groups (or new arrangement) viz: Southeast. South-South, south Wes, North East, North West and North Central that constituted Nigeria as a sovereign entity.

Research Questions:

This study asks the following questions:

- 1. What are the relevance of rotational presidency in Nigeria democratic setting?
- 2. What are the causes of political instability, unusual change of government cum total democratic failure in Nigeria?
- 3.Are the consequences for neglect and untrue practice of the principle of rotational presidency in Nigeria government?
- 4. What are the measures/polices alternative to consolidate unity in diversity and submerge or prevent national problems in Nigeria?

Research Hypothesis:

The researcher directionally and statistical indicates that there are/is significant difference and relationship between two variables under study. This research shall hypothesis that:

- 1. Rotational presidency in Nigeria democracy will create rooms for national integration, equal representation, political stability and peaceful co-existence.
- 2. Northern hegemony, ethnic and religion politics, unrestrained power by some ethnic group and absence of constitutional approval are the hindrance of rotational presidency in Nigeria democracy.

Research Design

The evaluated survey research design will be adopted in the study.

According to human (2017) evaluative design provides and ample opportunity 'or questionnaire or interview and analyses of data to produce a judgment concerning the merit, worthy, shortcomings of a programme or study. Therefore, this design is aim at making decisions about

the values, shortcomings, worthy and success or solution to the relevance of rotational presidency in Nigeria democratic setting.

Area of Study

The area of study is Nigeria; Nigeria got her independence in 1 960 and republic in 1963 from British colonial masters, she is one of the populated nations in African. She is made up of over (250) ethnic group with diverse language, socio-cultural affiliations and aspirations.

Nigeria has an area of 923. 768.005q km. and lies between latitude 4 and 14 East North of equator and longitude of 30 and 14 East of the green which meridian. It is within a tropical region. Nigeria has boundaries with Cameroon by North - East and Lake Chad by north-east which extended to Niger republic that touches northern part of Cameroon. On the south it is bound by Atlantic Ocean.

Nigeria has three (3) major ethnic groups viz. Igbo's, Hausa's, Yoruba's and three (3) region viz. Christian Islamic and traditional religion. Nigeria is heterogeneous in nature, Igbo's generally occupies eastern, Hausa northern, Yoruba Western part of Nigeria. Generally, the major occupations of Nigerians are trades, farming, and civil servants.

Currently Nigeria has six geopolitical Zone viz. South-East, South-South, South-West, North-East, North-West and North central.

Therefore; this study cut across the various ethnic groups or six geopolitical zones that made up Nigeria by which power of presidency should be rotated within the country.

Population of the Study

The population of this study will comprise the public servants, leaders of thoughts, women organizations, professional associations human right associations/politicians, students of tertiary institutions from each six geopolitical zones of Nigeria viz. south- east, south-south, south-west, north-east] north-west, north-central.

According to data from Nigeria dependency ratio demographic and social statistics UN statistics division of 2015, states that, Nigeria has the population of seventeen million eight hundred and eights four thousand, one hundred twenty-three point five (17884123.5 of 1.94%). This population is got from 36 states FCT that made up Nigeria which is the area of this study. Because of the vastness, till-ne frame and other constraints that involves, the researcher has selected five states from each geopolitical zone that made of 30 states to participate while twenty respondents were stratified selected from each zone that made up of 120 respondents drawn from total population (17884123.5), through stratified random sampling techniques.

The population distribution of each geopolitical zone; states in each zone, state participated in each zone and number of respondents from each zone is shown in the table 1 below.

More so, secondary data like textbooks, political bulletins, journals editorials, articles, newspaper and magazine were also employed to give reliable survey of this study in Nigeria democratic setting. Similarly, the questionnaire has four options formula scale rate for -rating the information from the respondents while 100% will stand as total percentage of each question, below is the description of the assessment.

In item four of table 4, it is shows that 62.5% of the respondents agree that avoidance of egocentric cum ethnic politics that does not promote the quest for Nigeria unity is one the measures of policies alternative to consolidate unity in diversity and submerge or prevent national problem in Nigeria while 37.5% of the respondents disagree to it.

Summary of Findings

In chapter four, the data collected for the study were statistically analyzed and presented in this chapter.

Frequency and percentage table were used for presentation. Each table contains information on the responses to the research questions and hypothesis that guide the study. Summated rating scales were used in measuring the data or stand points of the respondents in the table, for the study two hypothesis and four research question that were adopted.

Base on the findings, greater numbers of respondents under hypothesis agree that rotational presidency in Nigeria democratic will create room for national integration, equal representation, political stability and peaceful co-existence while lesser respondents had different opinion about that. In hypothesis two also greater numbers believe that the hindrance of rotational presidency in Nigeria democracy are northern hegemony, ethnic and religious politics, unrestrained quest for power by some ethnic group and absence of constitutional approval while few respondents had different view about it.

Furthermore, in research question, the number of respondents that maintained that political stability, liberal democracy unity, sense of belonging, equitable representation and mutual understanding about relevance of rotational presidency in Nigeria are greater than those respondent who opposed the motion. In table 2 of respondents agree that the cause of political instability unusual change of government and total democratic in Nigeria are inability to uphold the true principle of rotational presidency among zones, quest to get power at all cost, intersegmental imbalance and born to rule syndrome by northern are more than those respondents who had different opinion.

In table 3, great numbers of the respondents believe that the consequences for neglect and untrue practice of the principle of rotational presidency in Nigeria government are perpetual domination, democratic failure ethnic marginalization, agitation of power and rights insecurity, rancor, disintegration and war. Whiled those respondent that had different opinion are lesser in number.

In table 4, great numbers of the respondents agree that adoption, entrenchment into constitution and electoral act and true rotation, struck adherence, and avoidance of ethnic politics remain the measures or policies alternative to submerge or prevent national problem in Nigeria. With the above findings it is now obvious that rotational presidency has significant relationship or relevance's in Nigeria democratic setting. It also finds that rotational presidency has not gainful realities in Nigeria and it not a threat to Nigeria democracy or government rather it is the utmost panacea to imbed the tenets of democracy that is anchored on equity, fair play and fair compromise for unity in diversity and mutual understanding in Nigeria.

Discussion, Conclusion, Recommendations and Summary of Finding

Discussion: In fact, a lot of things were found out during the research.

It was gathered that rotational presidency is very relevant for political stability, equal representation and peaceful co-existence and unity in Nigeria democratic setting. Again, it were also discovered that causes of political instability, unusual change of government and total democratic failure in Nigeria are inability to uphold the true principle of rotational presidency among the six geological zone of Nigeria, the quest to get power at the national government at all cost, inter-segmental imbalance of power sharing in the structure of Nigeria federalism, and born to rule syndrome. It was also gathered that, the neglect and untrue practice of rotational presidency will lead to perpetual domination, insecurity, rancor, disintegration and war. It equally admitted that adoptions and entrenchment into constitution and electoral act, strict adherence of rotational presidency and federal character in power sharing and avoidance of ethnic politics will be the measures or policy alternative to consolidate unity in diversity and submerge or prevent national problem in Nigeria.

Moreso, it were gathered that northern hegemony, dominance, discrimination and marginalization over other section of the country are the threat to rotational presidency in Nigeria democratic setting while the principle of national presidency is a panacea for weaken ethnicity, tribalism and monopolization in Nigeria.

Conclusion

From the research findings the following conclusions were draw.

Rotational presidency is very relevant for political stability, stable democracy justice, fair play and co-operative existence and mutual understanding among all Nigeria. Unrestrained to power by northern are the threat to democracy in Nigeria. The principle of rotational presidency has not fully realistic in practices. It also conclude base on the analysis that political stability, liberal democracy, unity in diversity, ethnic/equal representation, sense of belonging, co-operation, are what rotation of presidency position will achieve as a relevance of adopted in Nigeria. Again, quest to get power at all cost, absence of constitutional approval, inter-segmental imbalance and instability to up-hold true principle of rotational presidency are the major causes of political instability and unusual change of government. Equally, neglect and untrue practice of the principle of rotational presidency in Nigeria government will leads to perpetual domination and total democratic failure.

Recommendations

To bridge the gap between rotational presidency and Nigeria democratic setting as two variables the following recommendation should be adopted and used. Nigeria government should provide constitutional models (standard, status quo or modusoperandi) upon which the INEC should draw their guidelines in working out national scheme which every eligible party shall uphold without refusal in Nigeria. Rotational presidency should be made compulsory for national leadership, state and local government in general election, every electorate should be mandated to vote for a candidates of his/her choice from consensus zone that will produce president. South east and other geopolitical zone that have not produced a president of vice presidency after military regime from 1999 till date should be constitutionally allowed to produce a president from 2019. Nigeria constitution should categorically state the compulsory zoning formula. Rotational presidency should be permanent feature of Nigeria as federal character principle. Nigeria should stop corruption and ethnic politics. All hand should be on deck to maintain Nigeria solidarity and tene of unity in diversity by preaching for peace in Nigeria. Nigeria should

take political game either winning or losing with the spirit of sportsmanship at all level irrespective of one's personal. Ethnic interest or aspirations.

Summary of the Findings

Greater number of respondents believe that rotational principle has much relevance, and has not attain the level of realities and it is not a threat to democracy in Nigeria setting, since if adopted and praticalised the above recommendations, it will build formidable, stable and enduring political atmosphere cum democratic tenets that is anchored on fair play justice, fair compromise of unity in diversity that is devoid of fear of domination, marginalization, discrimination, rancor, turmoil, and gerrymanding of any form.
